Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular meeting at <u>1300 Post Oak Boulevard</u>, <u>Suite</u> <u>2500</u>, <u>Houston</u>, <u>Harris County</u>, <u>Texas</u>, said address being a meeting place of the District.

The meeting will be held on Monday, January 22, 2024, at 7:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Public comments;
- 2. Review and approve the minutes of the December 18, 2023, Board of Directors meeting;
- 3. Bookkeeper's report, including financial and investment reports;
- 4. Adoption of Resolution Adopting List of Qualified Brokers Authorized to Engage in Investment Transactions with District;
